

## **Hospital Protocols During COVID-19 Pandemic That Led to “vaccine” Injury and Death**

### **Joint Testimony: Former Medical Assistant Mrs. Jummai Nache and Dr. Philip Nache**

My name is Mrs. Jummai Nache. My family and I emigrated from Nigeria in 2010/2011, and became naturalized United States citizens on August 15, 2025. I am a former Medical Assistant at the University of Minnesota Physicians (UMP) Health System. I was employed at UMPPhysicians from July 2019 until September 2021.

The cessation of my medical career is the direct result of hospital protocols coerced by my employer, upon patients and hospital staff, subsequent to the granting of an Emergency Use Authorization (EUA) by the Food & Drug Administration (FDA) on 11 December 2020. That EUA was granted for what Pfizer, government officials, and my former hospital employer (UMP) repeatedly promoted as a “vaccine” for COVID-19.

Throughout my UMP Medical Assistant work, my hospital employer alleged and coerced upon me that the sole remedy for combatting the COVID-19 disease was a (traditional) vaccine. However, at no time did UMP disclose that the EUA granted to Pfizer was not for a “standard art defined” vaccine, but in-truth was for a highly profitable but experimental gene therapy technology called mRNA or modRNA. At no time did UMP disclose that modRNA, what they and Pfizer marketed as a “vaccine,” had no prior use on humans. At no time did UMP hospital administrators disclose that they, the FDA, and Pfizer were fully aware of modRNA severe injury side effects, such as venous and arterial thromboembolism. Despite this awareness, UMP hospital administrators, under their threat of employment dismissal, coerced upon me a mandatory “vaccination,” which I submitted to in January 2021. It was the severe injury of thromboembolism that led to the amputation of my legs, my left hand, and fingers on my right hand. These life-saving emergency amputations ended my medical career.

The testimony proposed by Pastor Dr. Philip Nache and I will not profess expertise in vaccinology. But the UMP/modRNA non-disclosure scandal is contextual to the illicit, tyrannical and BigPharma-entangled behaviors of my former employer. Our hospital protocols testimony will detail why, administratively, our “vaccine” injury occurred. Our testimony will detail the conscious failure of UMP administrators; how under their moral and legal “duty to warn,” they failed to warn us about the dangers of modRNA gene therapy technology. Unlike other COVID-19 hospital protocol and BigPharma “vaccine” victims, we survived :

**SUMMARY:** In January 2021 the UMP hospital administrators announced that employees that did not submit to their “vaccine” mandate would be terminated. Our testimonial summary next:

If the UMP hospital administrators had disclosed their knowledge of (1) the COVID-19 needle was NOT a vaccine; that in truth it was an experimental gene therapy technology, (2) that under the EUA the modRNA was shielded by LIABILITY IMMUNITY, and therefore (3) we were offered basic Nuremberg levels of INFORMED CONSENT; we would have rebuffed the UMP hospital employment dismissal threats, and forfeited the Medical Assistant position in the name of ongoing prior perfect health.
