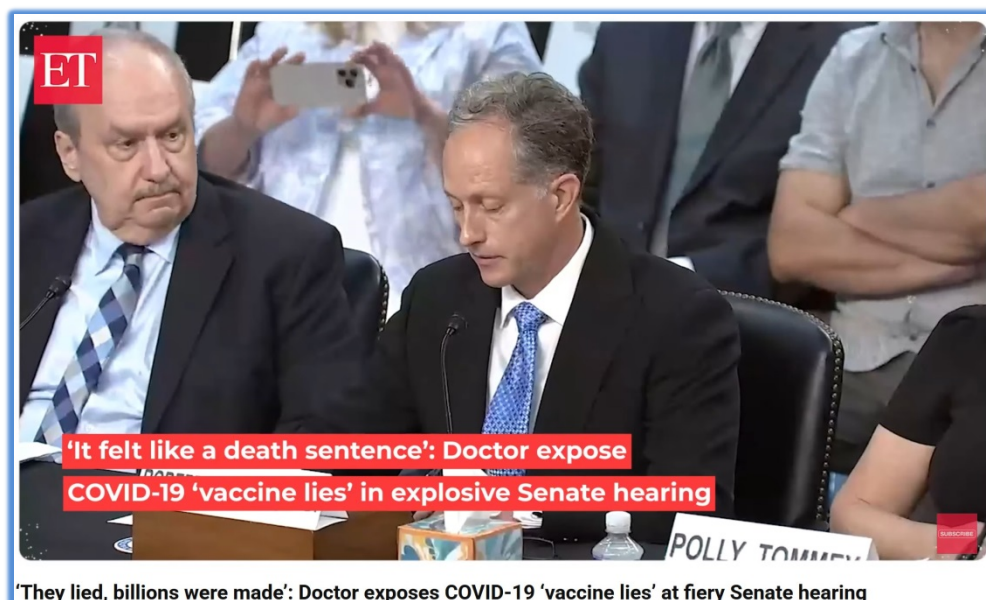

Dear Senator Johnson :

Similar to the witnesses that testified at the Reference, Mrs. Jummai Nache and Pastor Philip Nache are not Wisconsin constituents. We watched with great regard, Dr. Robert Sullivan :



However, a blaring historical fact emerges from the Reference :

The modRNA injuries described at the Reference **ALL post-date** the horror coerced upon a University of Minnesota (UMinn) Medical Assistant who was never informed of two crucial facts :

1. The needle that UMinn coerced into her 'model of health' body was **not** a vaccine; but instead was an experimental modified RNA (self-amplifying RNA) technology, that Bayer Pharmaceuticals CEO, Dr. Stefan Oelrich characterized as, ***"the leap."***



*"To tackle issues beyond COVID-19, we've seen vaccines as the perfect example . . . **We are taking the leap in selling gene therapy.** Ultimately the mRNA vaccines are an example for that. I always like to say if we had taken a survey two years ago, **in the public**, 'Would you be willing to take gene or cell therapy; and get it injected into your body?' **We would have probably had a ninety-five per cent refusal rate!"***

"The leap"? "Ninety-five per cent refusal rate"! Informed consent?

2. At no time did the UMinn "health authorities" inform Mrs. Jummai Nache, an immigrant from Nigeria, that the Pfizer needle they claimed was *"safe & effective"* was so dangerous that it was **shielded by the PREP Act scourge of LIABILITY IMMUNITY.**

From his testimony, the "vaccine" injury inflicted upon Dr. Sullivan occurred in November 2021 (Wall Street Journal, *This Doctor Elevated His Yoga Practice—20 Feet Off the Ground*, is dated 28 November 2021) . . . **many months after the amputations inflicted on Mrs. Nache.**

Had the modRNA horror inflicted upon Mrs. Nache *not* been censored (by everyone from UMinn "health authorities" to social media czar Ms. Susan Wojcicki CEO of YouTube), **the Dr. Sullivan modRNA injury, and so many others, would have been circumvented.**
