Dear US Attorney Pirro :

Nearly every division of the US Department of Justice should be in pursuit of Subjects 1 and 2. The recent Attorney General Todd Blanche memo on the National Fraud Enforcement Division :

*“The Department of Justice’s National Fraud Enforcement Division investigates and prosecutes those who commit fraud against **the American people.**”*

Fraud against the American people? How about the entire world?! The following headline resulted from an illegal Gain-of-Function (GoF) contract, not the zoonotic fairy tale promoted by the culprits of Subjects 1 and 2. **The GoF work at Wuhan was not conducted by Chinese bats :**

On 24 January 2024, Mr. Hans Mahncke of *The Epoch Times* issued a report :

“New FOIA Documents Reveal That 2018 Wuhan Lab Blueprint for Making Virus Perfectly Matches Covid”

Advocates of BigPharma have a new role as Constitutional experts. Their latest ploy is desperate; they unload their Front Man, while diverting world attention to him and Contempt of Congress :

But in the mind of **the American people**, Contempt of Congress is esoteric. In stark contrast, Subjects 1 and 2 can be pursued with evidence *“that is already in the public domain,”* offering immediate far-reaching judicial results; for both **the American people** and global humanity.

Let the COVID-19 criminals, and Mr. Fauci, take-the-fifth in those interrogations.

I am not discouraging your evaluation of the Contempt of Congress referral (by Senate Homeland Security and Governmental Affairs Committee); quite the contrary. But my opinion is tempered by DOJ procedural discipline and legal precedent. These range from 'Title 2, US Code Section 194' to *Wilson v United States* (1966). Entangled throughout is the allegation of political partisanship; by the very same charlatans that coddle COVID-19 criminals (SEE PAGES 6-8 BELOW).

Historically, Mr. Fauci has been in-contempt of any person or institution that did not **genuflect** to his bureaucratic and medical **divinity**. His role as Front Man for BigPharma and the COVID-19 Crime Syndicate is merely the latest of his various **Inquisitions**. Connected to the *lead-up* to the referral, nowhere was his contempt for the American people more evidentiary than his vicious assaults upon anyone that dared to **blaspheme** his farcical Year-2020 headlines :

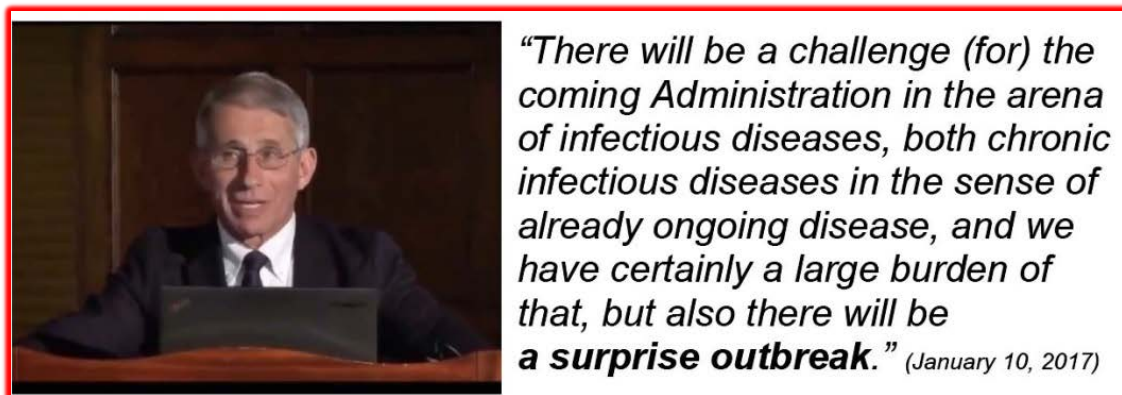
(A) Are we going to let a “*pathological liar*” and his co-criminals jeopardize, in any way, the relationship between the *good* people of China and the *good* people of the United States?

I am forwarding a complete copy of Enclosure 1. As shown on Page 4, President Trump offered a *very interesting* TruthSocial post on 1 September 2025 . . . I responded as follows :

“There was nothing ‘brilliant’ about Operation Warp Speed. There is nothing ‘great’ about a ‘vaccine’ that is so dangerous that its vested interests must cower behind LIABILITY IMMUNITY.”

The crux of Enclosure 1 . . . on Page 25 I made a simple request :

“Please issue an Executive Order that revokes the LIABILITY IMMUNITY that was granted for the modRNA technology (COVID-19 “vaccine”) ; retroactive to the FDA EUA date of 11 December 2020.”

*"I am now amending section XII of the Declaration to **extend the time period of PREP Act coverage through December 31, 2029**. COVID-19 continues to present a credible risk of a future public health emergency. COVID-19 continues to cause significant serious illness, morbidity, and mortality during outbreaks. The risk of domestic cases is high due to ongoing outbreaks that continue domestically and internationally in the year since the PHE for COVID-19 ended. Development of and stockpiling vaccines, therapeutics, devices, and diagnostics for COVID-19 continues to be needed for U.S. preparedness against the credible threat of a public health emergency due to outbreaks of COVID-19."*

Mr. Becerra has fooled no one . . . extending PREP Act coverage is synonymous with their true motivation : Extension of LIABILITY IMMUNITY. `Done after a secret meeting with a key beneficiary; a BigPharma executive that is central to Subject 1 :

On Page 25 of Enclosure 1 I made a request upon President Trump :

My rationale for a presidential EO approach, and now an approach to your office, is partially explained by Enclosure 2. Regarding LIABILITY IMMUNITY, it was the Legislative Branch that failed to serve their constituents, while instead groveling before BigPharma.

A. With traditional vaccine technology (methods that adhered to the **“standard art definition”**) a **prior pre-planned** design specification, and sequence manipulation *at the genetic level*, of pandemic-causing pathogens, **was not feasible**.

B. If my product required specialized methods or special tools to effect repair, I designed those in-lockstep, and released those as part of my engineering program. This is well-known engineering practice; there is nothing sinister about it . . . I never released a product that could not be fixed. But, in regard to COVID-19, please review Page 12 above :

“The COVID-19 ‘vaccine’ was not created in response to the SARS-CoV-2 virus, but the exact opposite.”

The **“2018 Wuhan Lab Blueprint”** (2019nCoV), re-labeled and re-branded as SARS-CoV-2, was a pre-planned engineered product, with genetic design that was confined to **“a vaccine that scientists have been working on for decades”** (Page 4 above).

I have been contacted by a number of people who have experienced adverse events post COVID-19 vaccination (from all three of the current vaccines). Many are healthcare professionals, some of whom I know. The symptoms do not fit together into a distinctive syndrome and most are not easily quantifiable or evaluated with standard laboratory testing. Clearly during mass vaccination you will get a lot of psychological reactions and it is hard to sort these things out. But the peoples' main complaint is that no one takes them seriously, no one knows how to treat them, and there is no effort to study this. These problems are not the sort that a system like VAERS would be able to detect, or even a more sophisticated population-based active followup such as CDC has, or a medical record based system such as BEST.

I think it would be worthwhile to do a study and evaluate a cohort of these individuals. 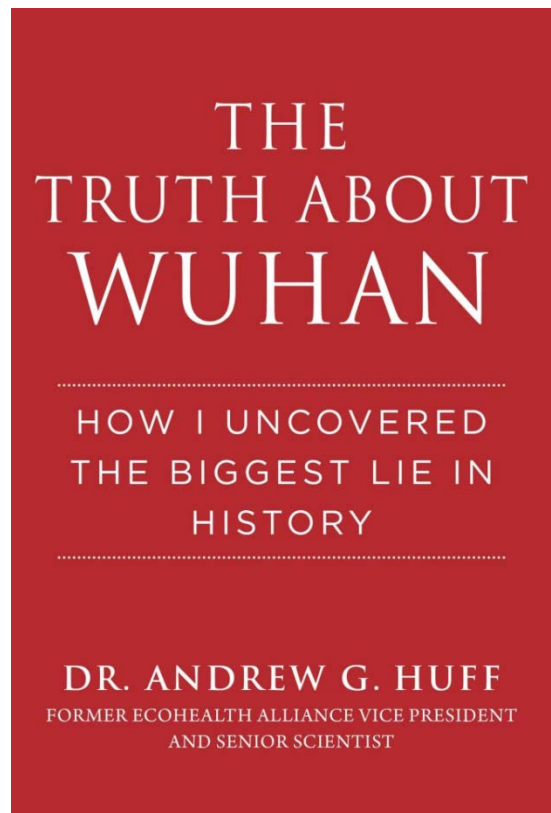

18 USC Chapter 115, Section 2381 – Treason
